This executive summary of the School Accountability Report Card (SARC) is intended to provide parents and community members with a quick snapshot of school accountability. About This School

The Wm. Finch Independent Study Program began in 1985 with 10 students and one teacher. Today, the CDS identified K-12 school boasts eight high quality teachers and averages 125 students. To ensure a quality education, families and students are assigned a teacher who provides an individualized instruction and planning for each student's success. We utilize a standards-based curriculum that includes new state-adopted textbooks, supplies tracking materials and student field trips designed to enhance the taught curriculum. New assignments are written and reviewed with families and students. Students share their successful comprehension of the standards of the previous assignments with their teacher and parents in weekly/bi-weekly conferences.

Wm. Finch School maintains a supportive learning environment and a faculty of outstanding teachers and staff committed to nurturing and developing the intellectual, physical, emotional and moral capacity of each student.

Wm. Finch School became a Charter on May 13, 2004. The school plan is to maintain the independent study focus. Two Learning Centers afford the school the ability to hold certain classes on-site.

School Description and Mission Statement (School Year 2008-09)

The mission of Wm. Finch Charter School is to provide a rigorous, quality educational choice that promotes student-parent-teacher-community partnerships.

Wm. Finch provides a unique public educational choice in Glenn County, blending classroom and non-classroom based instructional models. Students at Wm. Finch receive personalized attention to their individual learning styles, ability, interests, and aspirations. Classes are generally small, averaging no more than 25 students per certificated teacher. Wm. Finch parents are expected to be actively involved in their child's education, and to take personal responsibility for ensuring that their child is learning successfully. A collaborative relationship is developed between parents, students, community, teachers, and the school. Certificated teachers prescribe, evaluate, and teach using California grade level standards. Parents are trained in teaching strategies to support their student's independent home study instruction. Curricular benchmark assessments, detailed learning records, extensive student work portfolios, and annual state mandated tests are used to hold Wm. Finch students accountable for their learning.

Parent involvement is intrinsic in a home/independent study program such as Wm. Finch. Parents at Wm. Finch work with teachers toward the achievement of student goals and are in charge of the student's daily work. Parents are included in the governance and operation of Wm. Finch through the Advisory Committee, which has a membership much like a school site council that is required for non-charter public schools. The Advisory Committee participates in reviewing and recommending school improvements, soliciting the views of parents, teachers, and students, sharing in the efforts to improve the school and engaging the support of the community.

Wm. Finch is committed to working with parents to address parent concerns. Parents are encouraged to share their ideas and concerns throughout the school year, both directly and via the Advisory Committee.

Communications strategies include website updates, newsletters, teacher parent meetings, volunteer opportunities, and school surveys. Volunteer activities include: fundraising, senior and class project review and evaluation, participation in classroom activities, game days, field trips and hikes.

IX. Student Performance

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and ten through eleven. The CAPA includes ELA, mathematics, and science in grades two through eleven, and for science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA and mathematics for grades three through eight and science in grade five and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. Note: Only a sample group of California's schools and districts participate in the NAEP testing cycle. Therefore, students in any particular school or district may not be included in these results. The NAEP reflects state test results and is not reflective of either the LEA or the individual school. Comparisons of student performance on the NAEP and student performance on the Standardized Testing and Reporting (STAR) Program assessments cannot be made without an understanding of the key differences between the two assessment programs. For example, the NAEP only assesses grades four, eight and twelve and for long-term trends assesses grades nine, thirteen, and seventeen. Additionally, the NAEP only provides state test results for grades four and eight. The California Standards Tests (CSTs) are based on a different set of standards than the NAEP assessments. For example, the NAEP is not aligned with California academic content and achievement standards and, therefore, does not necessarily reflect the curriculum and instruction to which students are exposed in the classroom. The NAEP assesses reading and writing separately, while the CSTs assess English-language arts (ELA), encompassing reading as well as writing conventions, spelling, and grammar. Scores on the CSTs and other assessments are not directly comparable to those on NAEP. The averages and percentages presented are estimates based on samples of students rather than on entire populations. Finally, the questions students respond to are only a sample of the knowledge and skills covered by the NAEP frameworks.
